IN 2016, 9,239 ANIMALS WERE SUCCESSFULLY PLACED THROUGH THE BVSPCA'S CAMPUSES LOCATED IN WEST CHESTER, PA, NEW CASTLE, DE AND DOVER, DE. THE BVSPCA OPERATES ANIMAL HEALTH CENTERS AT BOTH THE MALVERN, PA AND NEW CASTLE, DE LOCATIONS; THIS GIVES PET OWNERS ACCESS TO QUALITY LOW-COST SERVICES RANGING FROM ROUTINE WELLNESS EXAMINATIONS AND VACCINATIONS TO SICK VISITS AND DIAGNOSTICS, TO SPAY/NEUTER AND SPECIAL SURGERIES.
