IN 2017, THE BVSPCA CARED FOR MORE THAN 14,000 STRAY, OWNER-SURRENDERED, WAYWARD OWNED AND ABUSED AND NEGLECTED ANIMALS WHILE ACHIEVING A 96% LIVE RELEASE RATE. THE BVSPCA PROVIDES ANIMAL PROTECTIVE SERVICES FOR CHESTER COUNTY AND MUCH OF DELAWARE COUNTY IN PENNSYLVANIA AND IT HOLDS A FIVE-YEAR CONTRACT WITH THE DELAWARE OFFICE OF ANIMAL WELFARE TO PROVIDE STATE-WIDE ANIMAL SERVICES FOR DOGS.
