IN 2021, THE BVSPCA CARED FOR NEARLY 19,000 LOST, STRAY, OWNER-SURRENDERED, AND ABUSED AND NEGLECTED ANIMALS WHILE ACHIEVING A 95% LIVE RELEASE RATE. THE BVSPCA PROVIDES ANIMAL PROTECTIVE SERVICES FOR CHESTER COUNTY AND MUCH OF DELAWARE COUNTY IN PENNSYLVANIA AND IT HOLDS A FIVE-YEAR CONTRACT WITH THE DELAWARE OFFICE OF ANIMAL WELFARE TO PROVIDE STATE-WIDE ANIMAL SERVICES. ANIMALS ARE PLACED THROUGH FIVE ADOPTION CENTERS: THE DOVER CAMPUS, THE NEW CASTLE CAMPUS, THE GEORGETOWN CAMPUS, THE WEST CHESTER CAMPUS, AND THE PLYMOUTH MEETING PET SMART EVERYDAY ADOPTION CENTER.
